The Performance Rights have been issued in accordance with Mr Sutherland’s Executive Services Agreement, which includes a “Long Term Incentive Plan” (approved by shareholders at the 2013 AGM), which takes the form of an issue of Performance Rights. Each Performance Right carries a right to one fully paid ordinary share.

The issue of an additional 170,000 Performance Rights under the Managing Director’s Long Term Incentive Plan has been approved by Shareholders at the 2015 Annual General Meeting.

The ability of Mr Sutherland to exercise the Performance Rights referred to above is subject to satisfaction of the performance criteria that is based on:

(a) Performance criteria 1: Total Shareholder Return (TSR)

Half (1/2) of the Performance Rights, 85,000, will vest based on the Company’s performance by reference to the TSR over the Performance Period when compared with the TSR for each company in a group of peer companies. The peer group of companies comprises the companies listed in the S&P/ASX 300 (ranked by market capitalisation) after excluding resource companies, banks and listed property trusts. A peer company continues to be included in the comparator group for the entire Performance Period, except where the company is delisted due to takeover or merger. New entrants into the ASX300 during the Performance Period are excluded.

The Company’s performance ranking within that group of peer companies at the end of the relevant Performance Period determines the number of TSR Performance Rights that will vest, as follows:

Half (1/2) of the Performance Rights, 85,000, will vest based on the Company's EPS performance, where a target range for the average annual growth in diluted EPS over the Performance Period of the EPS Performance Rights has been established to determine the number of EPS Performance Rights that will vest, as follows:
